# A. Introduction

We collect certain information (the *Data*) through our online services provided to you, whether for trial or rental (our *Service*). This privacy policy (the *Privacy Policy*) sets forth our policies and procedures surrounding the collection and processing of any such information.

The Data do not include the evidence collected by you in the course of using the Service, and the Privacy Policy is not intended to apply to that evidence.

#### B. When We Collect Your Data

We collect your Data when you visit and/or use our Service.

#### C. What Data We Collect

This section describes the Data that we collect from you when you visit and/or use our Service.

We collect the following personal information from users who register with our Service and use our products and services: name, username, password, e-mail address, mobile phone number, and time zone.

When you visit the Service, we use cookies to collect information to provide features to you. A cookie is a string of data our system sends to your computer or device and then uses to track your navigation through our Service. Cookies give us usage data, such as where you go at the site, and what you do so that when, for instance, you click on your browser's 'Back' button, our Service knows which page you want to navigate to.

As set out above, the Data do not include the evidence collected by you in the course of using the Service.

## D. Our Use of Your Data

This section describes how we use the Data that we collect from you when you visit and/or use our Service.

We use your personal information to create your account, to communicate with you about products and services you have registered for, and to offer you additional products and services. We also use your personal information to the extent necessary to enforce our End User License Agreement and to prevent imminent harm to persons or property.

We use cookies so that our Service can remember your navigation through our Service, in order to enable features such as the 'Back' and 'Forward' buttons on your web browser.

### E. How We Protect Your Data

We use commercially reasonable safeguards to help keep the information collected through the Service secure and take reasonable steps (such as requesting a unique password) to verify your identity before granting you access to your account. Unfortunately, even with these measures, we cannot guarantee the security of any information you transmit to our Service or guarantee that information on the Service may not be accessed, disclosed, altered, or destroyed. By using our Service, you acknowledge and agree that we make no such guarantee, and that you use our Service at your own risk. We take the security of your Data seriously, and if the security of your Data is breached, we will notify your designated point of contact of serious data breaches as soon as we reasonably can so that you can take appropriate measures.

When you no longer want your Data to be processed, and provided that there are no legitimate grounds for retaining it, we will delete your Data within a reasonable time after your request that we do so. You can also contact us to request details of your Data under our control.

## F. Third Party Access to Your Data and Other Information

As a general rule, we do not share your Data with third parties. However, we may disclose your Data to attorneys, collection agencies, or law enforcement authorities to address potential acceptable use violations, other contract violations, or illegal behavior. We may disclose any Data or other information demanded in a court order or otherwise required by law or to prevent imminent harm to persons or property.

If we sell or otherwise transfer part or the whole of the Service (e.g., in the course of a transaction such as a merger, acquisition, bankruptcy, dissolution, or liquidation), your Data may be among the items sold or transferred. We take the security of your Data seriously, and we will notify you of any such sale or transfer prior to it taking place, and ensure that the buyer or transferee is under the obligation to comply with this Privacy Policy. As noted above, these Data do not include the evidence collected by you in the course of using the Service.

#### G. Storage of Your Data

Your information collected through the Service may be stored and processed in the United States (*U.S.*) or any other country in which the Service maintains facilities. We may transfer your Data, including personal information, across borders, and from your country or jurisdiction to other countries or jurisdictions around the world. If you are located in the European Union or other regions with laws governing data collection and use that may differ from U.S. law, please note that we may transfer information, including personal information, to a country and jurisdiction that does not have the same data protection laws as your jurisdiction.

By registering for and using the Service you consent to the transfer of information to the U.S. or to any other country in which the Service maintains facilities and the use and disclosure of information about you as described in this Privacy Policy.

As noted above, these Data do not include the evidence collected by you in the course of using the Service.

# H. How Long We Keep Your Data

Whenever we collect or process your Data, we will keep it only for as long as is necessary for the purpose for which it was collected.

At the end of that period of time, your Data will be deleted completely.

#### I. Children's Privacy

We do not knowingly collect or solicit any information from anyone under the age of 16 or knowingly allow such persons to register for the Service. The Service and its content are not directed at children under the age of 16. In the event that we learn that we have collected Data from a child under age 16 without parental consent, we will delete that information as quickly as we reasonably can. If you believe that we might have any information from or about a child under 16, please contact us.
